Achieving full equality of access to higher education is a national priority, for people with disabilities, mature students who previously had not the opportunity to access higher education, those facing social and economic barriers, and minority groups, including the Traveller community.

To help make progress on this equality goal, your college gathers Equal Access information each year at registration on students' socio-economic background, disability and ethnicity and returns it to the Higher Education Authority.

With the information, the HEA is able to measure equality of access to higher education and allocate the resources needed to support students of all backgrounds and abilities.

The information gathered during registration is protected by robust data protection policies in your college and

in the HEA, in full compliance with data protection legislation, and subject to audit by the Office of the Data Protection Commissioner.

Equal Access information is stored alongside other student data in the HEA (including nationality, age, course details) but no data includes names or addresses. Anonymised equal access data may be analysed by the HEA for the purposes of developing evidence based policy in the area of equity of access to higher education, including analysis of the student experience and graduate outcomes. Only summary

data is published in this case and no individuals or small groups can be identified in this analysis.

All students are encouraged to respond to the Equal Access questions, however they are not mandatory and non-response will not prevent your registration at college or affect your eligibility for financial support.

Non-response may, however, have implications for the amount of State funding that is allocated to your college, and to the supports available to students who need them.

Chun an cuspóir comhionannais seo a shroicheadh, bailíonn do choláiste eolas gach blain ar Cothroime Rochtana, nuair a cháraíonn mic léinn sa choláiste, ar chúlraí socheacnamaíoch, míchumais agus eitneacht na mac léinn agus seoltar ar ais chuig Údaras um Ard-oideachas é.

Leis an eolas, tá an tUAO in ann cothroime rochtana ar an ardoideachas a thomhas agus na hacmhainní atá de dhíth chun tacaíocht a thabhairt do mhic léinn ó gach cúlra agus cumas a leithroinnt.

Tá an t-eolas a bhailítear tráth an chláirúcháin faoi chosaint beartais chosanta sonraí láidre i do choláiste

agus san UAO, i gcomhlíonadh iomlán le reachtaíocht chosanta sonraí, agus faoi réir iniúchadh ó Oifig an Choimisinéara Cosanta Sonraí.

Stóráiltear eolas ar Rochtain Chothrom le sonraí eile ar mhic léinn san Údarás Ard-Oideachais (UAO) (náisiúnacht, aois agus sonraí an chúrsa san áireamh), ach níl ainmneacha nó seoltaí sna sonraí sin. D'fhéadfadh an UAO anailís a dhéanamh ar shonraí rochtana cothroime anaithnide, agus na cuspóirí acu, polasaí bunaithe ar fhianaise a fhorbairt i réimse chothromas na rochtana ar ardoideachas, anailís ar eispéaraí na mac léinn agus ar thorthaí na gcéimithe san áireamh. Ní fhoilsítear ach

sonraí achoimre sa chás seo agus ní féidir duine nó grúpa beag ar bith a aithint san anailís seo.

Moltar do gach mac léinn na freagraí maidir le Cothroime Rochtana a fhreagairt. Ní gá iad a fhreagairt mura mian leat agus ní chuirfear bac ort clárú sa choláiste agus ní imreoidh sé tionchar ar do cháilíocht chun tacaíocht airgeadais a fháil mura fhreagraíonn tú iad.
