**How to calculate the total charge**

The fee is calculated by the number of credits in the modules repeated.

*((tuition fee + student contribution)/60 credits) x number of credits in modules repeated = total repeat tuition fee*

Example:

A student repeating on the Higher Certificate programme needs to repeat 3 modules. Each module is 5 credits.

$$\frac{250 + 3000}{60} = \underline{54.17} \times 15 = \underline{\underline{€812.49}}$$
